carpentry and/or art supplies that may not be listed above. I AGREE TO ASSUME FULL RESPONSIBILITY FOR ANY INJURY OR DAMAGES  
TO MYSELF, MY CHILD, THE CRAFT ROOM, LLC'S PROPERTY, TOOLS, PERSONS, FACILITY, OR WHEREVER THE CRAFT ROOM, LLC'S  
BUSINESS IS CONDUCTED AND ASSUME ANY RESPONSIBILITY OF COSTS THAT MAY INCUR.

I am aware there may be risks of serious harm and injury to my child while attending or participating in The Craft Room, LLC events,  
classes and workshops using such tools and supplies set forth above, as well as those not listed, and agree that my child will take  
proper precautions and adhere to safety instructions, recommendations, rules, warnings, and policies at all times – whether given  
orally or in writing. I recognize that not taking the proper safety precautions and directions – including, but not limited to – wearing  
masks, gloves and/or goggles, properly using tools and supplies, paying attention to detail and direction - may cause serious and  
possibly permanent bodily injury to my child or personal property damage and I assume full responsibility if such should occur. These  
dangers, risks and harms may be caused by the actions or inactions, including the negligence of, The Craft Room, LLC, any of its agents,  
employees, volunteers, owner, other patrons, my child or myself. Other risks or losses either known or unknown at this time may also  
occur. I FULLY UNDERSTAND THE RISKS AND DANGERS SET FORTH ABOVE AND ACCEPT ALL RESPONSIBILITY FOR ANY AND ALL INJURY,  
LOSSES, DAMAGES AND COSTS THAT MAY OCCUR AS A RESULT OF MY CHILD'S PARTICIPATION IN OR PRESENCE AT ANY AND ALL THE  
CRAFT ROOM, LLC WORKSHOPS, CLASSES AND EVENTS.

I further agree to release, discharge, and covenant not to sue The Craft Room, LLC, its owner, agents, employees or volunteers for any  
injury, loss, damage, loss or harm that may arise out of my child's participation in or presence at The Craft Room, LLC workshops,  
classes or any event to be held at the facility, or wherever The Craft Room, LLC's business is conducted, whether caused by The Craft  
Room, LLC, its owner, agents, employees, volunteers, another patron, any third party, my child or myself whether to me, my child, my  
personal property or my child's personal property. I agree that if I, or anyone on my or my child's behalf, makes a claim against The  
Craft Room, LLC, its owner, agents, employees or volunteers, I WILL INDEMNIFY, DEFEND AND HOLD HARMLESS EACH OF THE ABOVE  
NAMED AND THEIR INSURANCE CARRIERS FOR ANY AND ALL COSTS AND FEES ASSOCIATED WITH ANY SUCH CLAIMS, INCLUDING BUT  
NOT LIMITED TO, ATTORNEY FEES, COURT COSTS, LITIGATION EXPENSES, JUDGMENTS AND ANY OTHER COSTS THAT MAY ARISE  
FROM SUCH A CLAIM.

I agree that my child will not consume alcohol. I further agree that my child will not be under the influence of any prescription or non-  
prescription drugs that would impair my child's ability to follow direction and/or participate in any The Craft Room, LLC workshop,  
class or event. I assume all responsibility for my child's actions concerning alcohol and drug consumption. If my child does consume  
alcohol, prescription drugs and/or non-prescription drugs, I WILLINGLY ACCEPT ALL AND FULL RESPONSIBILITY FOR ANY PERSONAL  
INJURY AND/OR PROPERTY DAMAGE THAT MAY OCCUR DUE TO MY CHILD'S CONSUMPTION OF ALCOHOL OR DRUGS ON OR OUTSIDE  
THE PREMISES OF THE CRAFT ROOM, LLC.

I understand that projects, workshops, classes, demonstrations and directions, designs, and concepts are for personal use only. I agree  
that neither I nor my child will sell items made under the direction of The Craft Room, LLC for profit. I agree that neither I nor my child  
will take knowledge gained from The Craft Room, LLC or any of its agents and employees and use it for my or my child's own financial  
gain. I further agree neither I nor my child will share, teach or re-create projects and techniques learned at The Craft Room, LLC's  
facility or wherever The Craft Room, LLC's business has been conducted.

Governing Law. This Agreement shall be governed and interpreted under the laws of the County of Gloucester, State of New Jersey and under federal law, where applicable.

Severability. If any court of competent jurisdiction finds any provision of this Agreement to be invalid or unenforceable, such provision shall be considered removed from this Agreement and the remaining provisions shall be considered in full force and effect.

Entire Agreement. This Agreement contains the entire agreement of the Parties, and supersedes all other agreements and understandings, if any, written or oral, between the parties.

Waiver of Jury Trial. Any action by, between, or among any party or parties to this agreement with regard to any legal action to interpret or enforce the contract, or arising out of the contract, or otherwise concerning or relating to the contract shall be tried to the court only and not by a **jury**. For and in consideration of the mutual promises and covenants contained in this contract, each party hereto expressly waives any and all right to demand a trial by **jury** as part of any complaint, counterclaim, crossclaim, third-party action, or any answer or response to any of the aforesaid pleadings.

I HAVE THOROUGHLY READ AND HAVE A COMPLETE AND FULL UNDERSTANDING OF THE CRAFT ROOM, LLC'S POLICIES AND AGREEMENTS, AND I FURTHER UNDERSTAND THAT BY SIGNING THIS WAIVER, I VOLUNTARILY WAIVE AND SURRENDER SUBSTANTIAL LEGAL RIGHTS THAT I AND/OR MY CHILD MAY HAVE OTHERWISE HAD. I HAVE SIGNED THIS DOCUMENT FREELY AND WILLINGLY WITHOUT INDUCEMENT, DURESS, OR ANY ASSURANCES. I INTEND FOR THIS AGREEMENT TO BE AN UNCONDITIONAL AND TOTAL RELEASE OF ANY AND ALL LIABILITY ON BEHALF OF THE CRAFT ROOM, LLC.
